# **Purpose**

Gadsden State Community College (College) is soliciting a Request for Bid (RFB) from qualified vendors to deliver and install an Ironworker Machine.

Bidders may offer compatible equipment where brand and/or part or item numbers are provided.

# **Specifications**

# **Standard features**

- 1. Urethane Stripper Attachment that keeps material flat through the punching process, eliminating distortion. The shorter required stroke gives you a faster punching cycle.
- 2. Automatic Urethane Hold that downs clamps and releases material automatically with each stroke. Part movement is eliminated by clamping the part throughout the entire shearing cycle.
- 3. Visibility for a direct line of sight over the hold down bar allows the operator to easily and accurately line up cuts to the shear blades.
- 4. Flat Bar Shear for low rake angle shear design results in flatter and higher quality sheared parts. Shear blades have four useable edges giving you a longer life and less expensive blades.
- 5. Angle Shear for floating upper blade seats in the center of the angle prior to cutting minimizing distortion giving you a higher quality cut.

#### Warranty

Twelve (12) months, covering parts against defects in materials or workmanship.

\*Tooling holders only. Does not include punch or die.

Bending attachments must be designed to increase productivity on the punch end of the machine. 24" version mounts perpendicular to the beam that includes 4-way bending die with openings of 7/8", 1-1/8", 1-1/2" and 2".

#### Roller feed tables Item #4431850

The roller feed tables must be in 5' lengths and can be bolted together to make longer sections for fast, easy feeding of plate or angle. Must include 20" wide rollers for flat bar and 6" rollers in the angle section. Must be adjustable to accommodate floor height and machine type.

# Pipe notching attachments

The pipe notching attachments must mount easily on the platen table in place of the punch die block. Must be a single notch system that allows the notching of both sides of the pipe you must rotate the pipe and realign with the notching die for the second notch.

The pipe notching attachment must be made up of three separate pieces, the pipe notching die holder, the pipe notching die and the pipe notching striker.

- The pipe notching die holder must be a universal die holder that bolts to the platen table and should be able to accept 3/4" through 2" Schedule 40 Pipe Notching Dies.
- The pipe notching dies must be spring return die sets that mount in the pipe notching die holder. Standard sizes of pipe notching dies must be 3/4", 1", 1-1/4", 1-1/2" and 2" Schedule 40. Other sizes of pipe and tube notching dies must be available upon request (may require a different die holder).
- The pipe notching striker must be an extended flat bottom punch used in your standard stripper assembly to press down the pipe notching die.

#### **Bid Submission**

An original hard copy of the bid must be mailed or hand-delivered in a sealed envelope, marked with the bid name and number listed on the outside envelope to the address provided herein. Bids submitted after the due date and time will not be considered.

Include in your sealed bid envelope:

- 1. Bid Form
- 2. Notarized State of Alabama Disclosure Statement
- 3. Notarized Beason-Hammon Act form
- 4. Electronically signed *E-Verify MOU*
- 5. Descriptive literature detailing each equivalent item offered. If equivalents are not offered, descriptive literature is not required.

#### **Bid Evaluation and Award**

An award will be made all or none to the lowest responsible and responsive bidder(s) whose bid meets the requirements set forth in the RFB. The lowest bidder will be the bidder(s) offering the lowest total price.

# **Product Acceptability**

Unless specifically called for in the RFB, all products for purchase must be new, never previously used, and carry the manufacturers' standard warranty. Remanufactured, demonstrator, used or irregular items will not be considered.

Include literature detailing each equivalent item offered. Any item bid as an equivalent which lacks sufficient descriptive literature or technical information to enable complete comparative analysis, may be disqualified.

#### **Contract Period**

The College intends to award a contract to one bidder and establish a 12-month contract with the option to automatically renew for a second and third 12-month period. Price adjustments may be considered during any contract renewal period.

#### Form of Bid

All bids must be sealed when received. Electronic bids will not be considered.

# **Alternate Bid Responses**

The College will not accept and evaluate alternate bid submittals to the RFB.

# **Sales Tax Exemption**

Pursuant to the Code of Alabama, 1975, Title 40-23-4(A)(11), the College is exempt from paying sales tax. Prices are not to include sales tax. An exemption letter will be furnished upon request.

#### Inspection

It is the responsibility of the bidder to inspect the facilities (grounds, road access, and buildings) for delivery method, installation and/or set-up of materials, supplies and/or equipment.

#### Acceptance

The responsibility of determining the acceptability of any products offered rests solely with the College.

#### **Pre-Bid Conference**

A pre-bid conference will not be required/held.

#### **Intent to Award**

Gadsden State will issue an "Intent to Award" before a final award is made. The "Intent to Award" will continue for a period of fourteen (14) calendar days, after which the award will be final provided there are no protests. A detailed explanation of this process may be reviewed in the Alabama Administrative Code, Chapter 355-4-6-.01. All protest communications filed via email must be sent to: FiscalServices@acccs.edu.

#### **Modification or Withdrawal of Bids**

Bids may be modified or withdrawn by written notice if received at the place designated for receipt of bids, prior to the bid due date and time.

#### Late Bids, and Late Withdrawals

Any bid submission or withdrawal received after the specified due date and time at the place designated for receipt of bids will be considered late.

#### **Responsibility and Responsiveness**

Bids will only be considered by a bidder who has submitted a bid which confirms in all material aspects to the RFB.

#### **Bidder Responsibilities**

The bidder agrees to indemnify, defend, save the College, the Alabama Community College System and its Board of Trustees (hereinafter Releasees) harmless from any and all claims, demands, actions, debts, liabilities, judgments, costs, and attorney's fees arising out of, claimed on account of, or in any manner

predicted upon loss of or damage to property or injuries to or the death of any and all person whatsoever, in any manner, caused or contributed to by the bidder, its agents, servants, or employees, while in, or about College premises, or while going to or departing from same, and to save the Releasees harmless from and on account of damages of any kind which the Releasees may suffer as the result of the acts of any of the bidder's agents, servants or employees in or about the performance of any contract between the bidder and the College.

The bidder shall indemnify, defend and hold the Releasees harmless for any liability incurred by the Releasees because of the non-payment, for any reason, of any debt or obligation for which the bidder has agreed to bear responsibility for payment, including the Releasees attorney's fees, costs of litigation and the amount of any judgment or extra judicial settlement entered into by the College, including interest.

Any defective work or materials, non-conformance to bid requirements, damaged materials, or unsatisfactory installation shall be corrected to the College's satisfaction by the successful bidder at no additional charge. Unless specifically called for in the RFB, all products for purchase must be new, never previously used, the current model and carry the manufacturers' standard warranty. Remanufactured, demonstrator, used or irregular items will not be considered.

# **College Rights**

College reserves the right to reject any or all bids, or any part thereof, and to waive any technicality in the bidding in the best interest of the College.

College reserves the right to purchase according to availability of funds.

College may cancel any contract resulting from an award of this RFB at any time with 15 days' written notice of termination.

Payment shall be contingent upon the College's inspection of and satisfaction with materials received.

#### **Insurance**

The bidder shall purchase and maintain such insurance as will provide protection from claims for damages because of bodily injury, sickness, or disease, or death of any person including claims insured by standard personal injury liability, policies, and from claims for injury to, loss, or destruction of tangible property, including loss of use resulting there from, any or all of which may arise out of or result from bidders operations under the scope of work, whether such operations be by offer anyone directly or indirectly employed by offer for whose acts offer may be legally liable. This insurance shall include the types and specific coverage(s) and be written for not less than any limits of liability required by law. Insurance must include, but is not limited to, coverage for commercial general liability, commercial automobile liability, worker's compensation, and employer's liability coverage. The Releasees shall be named as an additional insured on all policies. Before an award is made, the successful bidder must provide a copy of its Certificate of Insurance.

#### **Licenses and Permits**

The bidder must obtain and maintain, any and all necessary licenses and permits, and comply with all applicable Federal, State, and Local laws in conjunction with the performance of the scope of work. The College may request valid copies of necessary licenses and permits.

# **State of Alabama Disclosure Statement**

Section 41-16-82 of the Code of Alabama 1975 requires the Vendor Disclosure Statement to be completed and filed with all bids, bids, contracts, or grant bids to the State of Alabama in excess of \$5,000. In

circumstances where a contract is awarded by competitive bid, the Statement shall be required only from the person receiving the contract and shall be submitted with the offer.

# Beason-Hammon Alabama Taxpayer and Citizen Protection Act

As required by Section 31-13-9(k) of the Code of Alabama 1975, the supplier agrees to the following: "By signing this contract, the contracting parties affirm, for the duration of any agreement that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. #### Certification Pursuant to Act No. 2006-557

Section 41-4-142 of the Code of Alabama 1975 (Act No. 2006-557) provides that every bid submitted and contract executed shall contain a certification that the supplier, supplier, and all of its affiliates that make sales for delivery into Alabama or leases for use in Alabama are registered, collecting, and remitting Alabama State and local sales and use tax, or simplified seller use tax, and/or lease tax on all taxable sales and leases into Alabama. By submitting this bid, the bidder is hereby certifying that they are in full compliance with Section 41-4-142, they are not barred from bidding or entering into a contract as a result, and acknowledges that the awarding authority may declare the contract void if the certification is false.

# **Debarment and Suspension**

Per e-CFR §200.214 Suspension and debarment. Non-Federal entities are subject to non-procurement debarment and suspension regulations implementing Executive Orders 12549 and 12689, 2 CFR Part 180. The regulations in 2 CFR Part 180 restrict awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in Federal assistance programs or activities. By submitting this bid, the bidder is hereby certifying that they are in full compliance with CFR 200.214.

#### Debarment and Suspension Certification:

- a. The vendor certifies to the best of their knowledge and belief, they are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from a covered transaction by any Federal department or agency;
- b. That the vendor has not within a three-year period preceding this agreement been convicted of or had a civil judgment rendered against them for commission of fraud or criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, State or local) transaction or contract under a public transaction; violation of Federal or State antitrust statues or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

Furthermore, the bidder acknowledges that any resulting contract may address breach of contract, termination for cause and the Equal Employment Opportunity clause provided under 41 CFR 61-1.4(b).

#### **Additional Terms and Conditions**

The following provisions shall take precedence over any and all contrary or conflicting provisions of the agreement between the parties and shall govern the rights and obligations of the parties: This agreement shall be governed by and construed in accordance with the laws of the State of Alabama without giving effect to any choice- or conflict- of- laws, provisions, or rules (whether of the State of Alabama or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than those of the State of Alabama. It is further agreed that the terms and commitments contained herein shall not constitute a debt of the State of Alabama in violation of Section 213 of the Constitution of Alabama of 1901, as amended by Amendment Number 26. If any provision of this agreement shall contravene any statute or constitutional provision, either now in effect or which may be enacted during the term of this agreement, then the conflicting provision of this agreement shall be deemed null and void. Contracting party/bidder understands, acknowledges, and agrees that its sole and exclusive remedy for any claim which may arise from or relate to this agreement is to file a claim with the Board of Adjustment of the State of Alabama. By signing this contract, the contracting parties affirm, for the duration of this agreement, that they will not violate federal immigration law or knowingly employ, hire, for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of this agreement and shall be responsible for all damages resulting there from. This agreement constitutes the sole and entire agreement of the parties to this agreement with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, negotiations, and agreements, both oral and written, with respect to such subject matter. In accordance with the recommendations of the Governor and the Attorney General of the State of Alabama, the parties shall consider settling all disputes arising from or related to this agreement by using appropriate forms of nonbinding alternative dispute resolution. In the event of proration of the fund from which payment under which this agreement is to be made, the agreement will be subject to termination. This agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. In compliance with Act 2016-312, the contractor hereby certifies that it is not currently engaged in, and will not engage in, the boycott of a person or an entity based in or doing business with a jurisdiction with which this state can enjoy open trade. It is understood that there is no entitlement to any state merit system benefits to anyone working under this agreement.


